As of February 1, 2021, possession of drugs within certain amounts is no longer a crime under Oregon state law. It is now a violation, punishable by a maximum fine of \$100. The fine may be dismissed by completing a health screening within 45 days of receiving a citation. To complete the screening, call 503-575-3769 or 541-575-3769.

What are the amounts of drugs that are decriminalized?

- Under 1 gram of heroin
- Under 1 gram, or fewer than 5 pills, of MDMA
- Under 2 grams of methamphetamine
- Under 2 grams of cocaine
- Under 40 units of LSD
- Under 12 grams of psilocybin
- Under 40 units of methadone
- Fewer than 40 pills of oxycodone


